The amendments have been made to the number of Laws of Azerbaijan Republic about media. According to the amendments, the words "means of mass communication" were replaced by the word "media".

The relevant amendments have been made to the following Laws: Civil Code, Criminal Code, Tax Code, Code of Administrative Procedure, Migration Code, Urban Planning and Construction Code, the Law on "Courts and judges", the Law on "Insolvency and bankruptcy", the Law on "Information, informatization and information protection", the Law on "Freedom of information", the Law on "Investment funds", the Law on "Lotteries", the Law on "Electronic signature and electronic document", the Law on "Traffic", the Law on "Mortgage" and etc.

With this, the scope of the law has been relevantly expanded to include the definition of the emergency environment of a social nature. A number of regulations have been reflected in the revised version of the Law including the chapter "Regime of environment of social emergency character".

# 25 April, 2023 Responsibility for violation of media legislation

Amendments have been made to the Code of Administrative Offenses regulating responsibility for the violation of media legislation.

The Article 381 is amended and now comprises responsibilities for a number of violations in the field of media. Amended Article 388 regulates responsibility for abuse of media freedom and journalistic rights.
