*Amendment to the Law on  
"Private medical activity"*

According to the amendment, in accordance with the Law on "Cashless settlements", payments for medical services provided **by individuals engaged in private medical practice**, along with the private medical institutions, within the framework of a single transaction for medical services, exceeding five hundred manats, are carried out only in a cashless manner.
