## **Updates**

Amendments have been made to the Migration Code providing **additional grounds** for granting or extending permanent and temporary residence permits to foreigners and stateless persons:

52.1.2. taking into account the cases stipulated in articles 52.1.3-52.1.5 of this Code, if the total amount of investment in the country's economy is at least 500,000 manats;

52.1.3. If he owns real estate worth at least 200,000 manats in the territory of the Republic of Azerbaijan;

52.1.4. If there is cash in the amount of at least 200,000 manat based on a term deposit agreement in banks operating in the Republic of Azerbaijan;

52.1.5. If he owns investment securities of legal entities 51 percent or more shares of which are owned by the state with a nominal value of at least 200,000 manats;

The additions have been made to the Law on "Banks" in accordance with the changes to the Migration Code.

According to the amendments, as one of the cases for providing information on bank secrecy – "Information about the term deposit of foreigners or stateless persons who have received permission to live temporarily or permanently in the territory of the Republic of Azerbaijan by depositing funds in a bank operating in the Republic of Azerbaijan on the basis of a term deposit agreement is provided to the relevant executive authority in the cases determined by the Migration Code of the Republic of Azerbaijan".

The additions have been made to the Law on "Stock market" in accordance with the changes to the Migration Code.

According to the amendments, as one of the cases for disclosure and protection of securities information – "Investment securities of foreigners or stateless persons who have received temporary or permanent residence permit in the territory of the Republic of Azerbaijan, having state securities or investment securities of legal

entities with 51 or more percent of their shares (shares) owned by the state, are provided to the relevant executive authority in the cases specified by the Migration Code of the Republic of Azerbaijan".

With the amendment to the Law on State registration and state register of legal entities, the Notary office can obtain **information about the founders (participants) of commercial legal entities and their shares** in the charter capital through electronic information system based on an electronic request in accordance with the Law of the Republic of Azerbaijan "On Notary".
